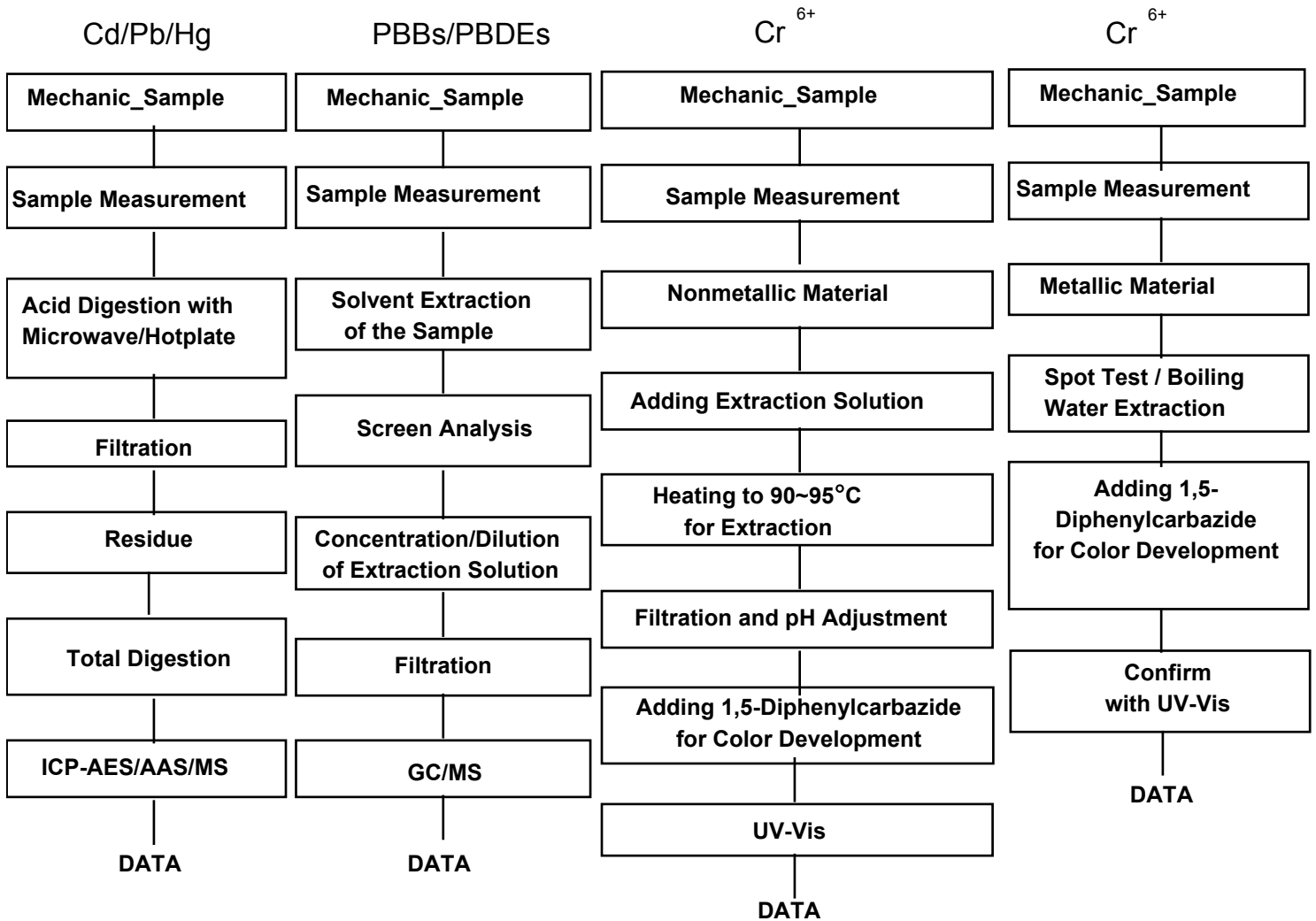
Picture of Sample as Received:

Testing Flow Chart for RoHS:Cd/Pb/Hg/Cr⁶⁺ /PBBs&PBDEs Testing

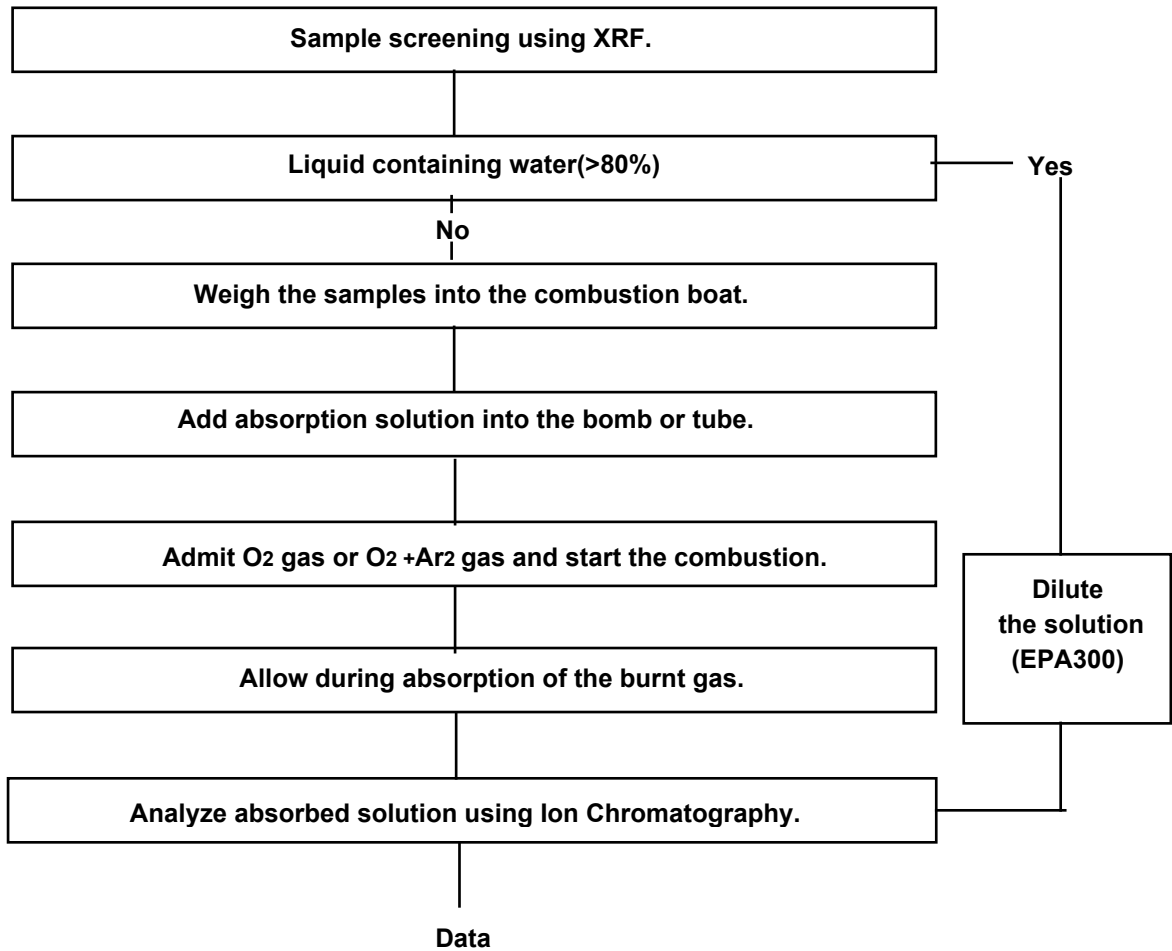


The samples were dissolved totally by pre-conditioning method according to above flow chart for Cd,Pb,Hg.
